## **MATTERS OF INFORMATION**

1. 2016 State Fair General Updates.

Acting Ag Program Director Carlson reported that all Competitions are underway and we are accepting applications. Olive Oil judging is coming up and we have 191 entries, compared to 140 last year.

Marketing Director Castleberry commented that we have a 46% increase of concerts ticket sale over last year and a 280% increase for Admission packages.

CEO Pickering commented that the Sacramento Ad Club presented their awards and Cal Expo received the Gold Award for our advertisement campaign. Glass Agency received the highest number of awards for the Ad Club of any agency in Sacramento.

AGM Shell reported that our Commercial and Concession applications are going strong. There is a waiting list for Commercial Vendors and for Food Concessions.

CEO Pickering announced that 2 of our food vendors had family members recently pass away and we extend our condolences to them.

CEO Pickering reported that, admission and parking rates have not changed since 2008 and will remain the same. There will be 10 days of live racing this year. Layout adjustments are being made for 2016. We are working on more shade and more tables and chairs with shade. We are looking at creating a 3<sup>rd</sup> community act level stage. The Fallen Heroes have put together a nice display honoring the State's fallen heroes. This is a large indoor display and staff is working to find an area that can accommodate it along with working out security details. The challenge is that the display needs a large space, roughly 20 feet wide by 130 feet long. Staff is also working on a Code of Conduct for the State Fair. Our Police Department along with other departments have commented and it will soon be ready for Public Comment.

CEO Pickering mentioned that Assembly member Adam Gray has introduced two bills that we are tracking, as they could assist all Fairs in California.

Chair Ochoa accepted a motion to adjourn.

It was moved by Director Chong and seconded by Director Hime. **All in favor, motion carried unanimously.**
