a. Approval of Council Meeting Minutes from September 17, 2015 and Council Meeting Minutes from November 19, 2015 with modification to September 17 minutes. Council Member Kallirai moved to approve. Council Member Johnson seconded. Motion passed.

6) STAFF & MEMBER UPDATES

- a. Cal Expo Update Rick Pickering reported that:
 - He attended the World's Fair during Food Week to present information about California agriculture and the State Fair.
 - The Hmong Festival successful and well attended.
 - Global Winter Wonderland was successful with nearly 200,000 attendees. Great cultural attractions and events.
 - International Sportsman's Show, Dinosaurs and Home & Garden started the year off well with increased attendance and revenue.
 - He explained the free show format for State Fair concerts and related that 2016 is mostly booked.
 - Discussed possibility of programming tied the Summer Olympics.
 - Reported on U.S. Pro Rugby and Sac Republic games.

b. Program Update -

- 20 different competition handbooks are under way and will be posted to the website as they are finished. They have varying entry deadlines. New this year is Student Showcase and Amateur Photography. Director Wright encouraged the Council to review the website.
- Main feature will be a California Transportation exhibit, the State Fair is working with the State Library and the Transportation Agency.
- Distributed entertainment applications and plans, asked for input from the Council.
- Reported that the Kitchen and Farm Programs would add special features in 2016. Gearing up for crop rotation due to school tours in Spring.
- The Sacramento NAACP is celebrating 100 years and will have an exhibit at the California State Fair..
- c. Marketing Update Director Wright reported that many awards were won by California State Fair at Western Fairs Association and the International Association of Fairs & Expositions, including the prestigious "Overall Best Marketing Campaign". Director Wright played a video that summarized the many 2015 successes.
