- 1) CALL TO ORDER The meeting was call to order at 5:33 p.m. by Chair Johnson.
- 2) ROLL CALL Role was taken and a quorum was present. Council Member Chavez was not present and asked to be excused. Council Members Brown, Cater, Colbruno, Mateo and Alternate Council Member Pannell were not present.

Council Member Banuelos moved to excuse Council Member Chavez. Motion was seconded by Council Member Earl. **All in favor, motion passes unanimously.**

#### 5) STRATEGIC PLANNING

- a) What is strategic planning?
  - Vice Chair Nagendra reported that this meeting is part 1 of the Strategic Planning for the CAC. The objective for today is a discussion of where we as the CAC want to go in the next 18 months from now. Also as part of this journey we want to be able to picture ourselves 18 months from now and make sure we come up with a plan that helps us to achieve what we really see from today to 18 months from now. Some of you are familiar with strategic planning and some of you are not. Strategic Planning is just a fancy word for Game Planning. Part of today we will focus on the "What". What are we going to do in the next 18 months? Our meeting in August we will be discussing the "How". To help with the 2 sessions, Twiana Armstrong-Bryant will be our facilitator.
- b) What has CAC been doing? Ms. Armstrong-Bryant went on to explain the ground rules: Seek first to understand, stay present, inquiry vs. advocacies. The group went on to discuss and determine 26 actives that the Cultural Council is currently doing. (See attached draft of the Mission Statement and list of actives)

  - The group took each activity and discussed whether or not it aligned with the By-Laws and Mission Statement. They numbered each activity to align with the Mission Statement. It was discussed that there may be other action items to put on the list. It was asked that Councilmembers send to Chair Johnson and Vice Chair Nagendra their additional ideas by August 10, 2020 to ensure it will be included at the next Strategic Planning session on August 20, 2020.
