Chair Durfee called the public meeting to order at 10:02 a.m.

### 2. ROLL CALL

Roll call was taken and a full quorum was present.

### 3. INTRODUCTION OF GUESTS AND STAFF

Chief Deputy General Manager Tom Martinez introduced Cal Expo staff and Guest. Mike Francesconi, Branch Chief of Fairs & Expositions of California Department of Food & Agricultural thanked the Board of Directors for helping with the Sacramento County Fair.

### 7. New BUSINESS

a. Review and Approval of proposed Cal Expo State Fair Bylaw Amendments to provide term limits for Agricultural Advisory Council and Cultural Advisory Council.

Director DiMare stated that the Board has discussed over the pasted several years to review/update the By Laws for the Advisory Councils. The Board

discussed updating the Ag Advisory Councils (AAC) by laws to be in line with the Cultural Advisory Council. The AAC did not meet during COVID. Director DiMare and Vice Chair Hime met with the AAC leadership to discuss changes in the by laws. At the April 14, 2022, AAC meeting the group voted to accept the revised by laws. Director Di Mare wanted to thank the AAC members for their support over the years.

### MOTION:

Director DiMare made a motion to approve the Cal Expo State Fair bylaw Amendments for the Agricultural Advisory Council and Cultural Advisory Council. Vice Chair Hime seconded the motion. Chair Durfee asked for a roll call vote Director Barkett; yes; Director Choi, yes; Director Chong, yes; Director DiMare, yes; Director Gbeh, yes; Director Mallel, yes; Director May, yes; Director Salinas, yes; Vice Chair Hime, yes; Chair Durfee, yes; Motion passes unanimously.

**b.** Review and Approval of proposed Enhancements to the Code of Conduct for Events and the State Fair

Cal Expo Police Chief Walton explained that he had been involved in the research and developing the code of conduct in 2016. Our code of conduct of 2016 has been in place without change which gives credit to the fact we did our job well the first time. He went on to explain the proposed removal of the no mask policy, proposed clear bag policy and the proposed unaccompanied minor policy for Friday, Saturday and Sunday after 6pm. These enhancements have been reviewed by several community activist and they support the changes. Director Chong asked if there is a limit as to how many minors can enter with an adult and do the adults have to stay with the minors at all times? Chief Walton stated that at this time there is no restriction of the number of minors entering with an adult and staying with minors during the whole visit is something we can't control. Director DiMare had some questions about the bag policy and parental and medical. In regards to diaper bags, strollers and medical necessity. Chief said that the medial necessity for example is the O2 tanks in a bag and the diaper bags fall under parental necessity. Director DiMare also had some concerns with adults entering with minors and it effecting attendance. Vice Chair Hime had comments about the doing away with the not mask policy. Hime suggested amending that portion to read: "No Face Mask Policy: The 2016 Code of Conduct included a "No Face Mask" policy, which discouraged individuals from trying to hide their identity while attending events at Cal Expo. Due to public health concerns related to COVID, it is anticipated that event attendees may wear medical face masks into the near future. Consequently, Staff is recommending that the No Face Mask policy be should reflect this change to the Code of Conduct at this time."

Director Gbeh asked if the adult entering with minors needed to have the same name as the minors. Chief Walton replied with the only example he can use is from Fresno where the adult entering must provide some ID that shows they are the parent or guardian of the minor. Directors Mallel and May suggested that from their experiences signage and getting the information out is key to making this work.

### MOTION:

Vice Chair Hime made a motion to direct staff to move forward with placing the proposed Code of Conduct policy enhancements as amended on Cal Expo's website for review and comment for the next 30 days. Director May seconded the motion. Discussion: Director Gbeh thought that medical mask may be too controversial and suggested using a more benign word. Director May suggested the word health and the maker of the motion accepted that. Chair Durfee asked for a roll call vote Director Barkett; yes; Director Choi, yes; Director Chong, yes; Director DiMare, yes; Director Gbeh, yes; Director Mallel, yes; Director May, yes; Director Salinas, yes; Vice Chair Hime, yes; Chair Durfee, yes; Motion passes unanimously.

### 8. OLD BUSINESS

a. Update on the 2022 California State Fair

Chief Walton — Chief Walton gave a brief summary of how the Police Department is getting ready for State Fair. Recruiting, updating metal detectors, training and hiring for metal detectors, updates for Police Policies and training manuals are some of the pre-fair projects.

Mitch Pryor, Chief of Plant – Maintenance and Operations – Recruiting and hiring is ongoing He proceeded to give a summary of activity that is happening on the grounds and in the buildings to get ready for fair.

Marcia Shell – Asst. General Manager – Events – AGM Shell gave an update on shows that are happening at Cal Expo prior to State Fair. Competitions – AGM Shell briefed the Board on all the competitions that are opening or opened. Information is online at State Fair's web site. Advance online tickets for State Fair will start on May 11<sup>th</sup>. Programs – identifying buildings in Expo Center for all the exhibits.

Tom Martinez-Chief Deputy General Manager – CDGM Martinez explained to the board his vision for Media and VIP Tours interns. He went on the say that he has one spokesperson on board for State Fair and is working with another. He stated the Cal Expo has had 1 successful Job Fair and will be having another Job Fair May 6<sup>th</sup>. He then discussed the Mariachi Competition and how it will look different due to COVID.

CEO Pickering – gave a brief summary of our advertising (with un/common) will begin in May concentrating on advance ticket sales and concerts. Event Partnership had targeted \$1.6 million in cash which they have already reached and is pushing to \$2.0 million in cash for State Fair. Pickering then went on to explain that Food Vendors, Commercial Vendors and Spectra are all having a hard time finding employees.

b. Update on Inaugural State Fair Cannabis Competition

This item was moved to be heard after Item #4 Public Comment on Matters not on the Agenda.

Chair Durfee explained the order in which this item will be heard. Chief Deputy General Manager Martinez, along with Cultivar Brands will give background information and an update of the cannabis competition. Dr. Lynn Silver will give a 10 minute presentation against the cannabis competition and Dustin Moore will give 10 minute presentation about Proposition 64 which legalized recreational cannabis. Then there will be Public Comment, followed with a Q & A for the Board of Directors and then a Board discussion.

Chief Deputy General Manager Martinez gave a brief summary of the staff report.

<u>James Leitz</u>, CEO of Cultivar Brands, informed the Board of that he has been involved in the development, marketing etc. of the State Fair Cannabis competition since 2019. He went on to report that there have been over 300 entries for this science based award and he is excited moving forward with the competition.

Brian Applegrath, Co-founder and CSO of Cultivar Brands, told the Board that he echo's James' comments. He talked about how complex the cannabis plant is and the therapeutic properties of the plant. He also thanked the State Fair Board for acknowledging industry and for allowing an awards program and a platform to educate around the living plant in the ground.

<u>Dr. Lynn Silver</u>, thanked the Board for allowing her to share the concerns of the public health and substance abuse community. Dr. Silver presented a power point presentation (attached) and stated that the concern is not about being pro or anti cannabis or being for or against legalization but for awarding a prize for the highest THC cannabis. She ended with requests that State Fair reverse course and cancel the THCa prize, drop the prize in subsequent years and not to provide marketing tools based on the prize.

<u>Dustin Moore</u>, former Campaign Manager for Prop 64, which legalized cannabis for recreational use in the State of California. Mr. Moore thanked the Board for allowing him to address the Board He talked about how he became aware of Cannabis through a family members illness. He stated that in 2012 he started working to legalize Cannabis and became the Campaign Manager for Prop 64. Prop 64 passed in 2016 under scoring Californians believes in the importants plant and the role in plays in this society. The State of California developed the strictest provisions in the nation to insure the highest levels of health and safety. State Fair criteria was born out of the State's existing testing structure. Moore went on to thank Dr. Sliver for her presentation today. He stated that it is only through this type of dialog that we can continue to advance education and understanding which is what this event will facilitate.

Brian Applegarth read a letter from Dr. Bonnie Goldstein in favor the cannabis competition.

### **Board of Directors Questions & Answer**

Director DiMare stated that as Board Members competitions are something we should take seriously, have discussions and vote on.

Vice Chair Hime asked several questions. What is the award process, who can participate and what are the awards.

CEO Pickering explained that there is a 29 page competition handbook that addresses these questions on Cal Expo State Fair's website. This competition was created to mirror other State Fair competitions. Vice Chair Hime then asked if this competition was for large corporate growers or small family farm growers. Pickering answered that the competition is for license growers. Then Vice Chair Hime asked when the recognition is awarded is there any restriction on how that person uses that award/recognition. What can our logo be used on? CEO Pickering stated that he can't remember seeing a blue ribbon on a bottle of wine. But that doesn't mean that you can't do that as there are no restrictions in place at this time. However, as a Board you can make restrictions if you choose.

### MOTION:

Director Salinas made a motion to approve the Cannabis competition as planned. Director Mallel seconded the motion. Chair Durfee asked of any discussion - Vice Chair Hime asked to clearly delineate how the awards can be used (in advertising) by the Board. Staff state that they would work closely with Cultivar Brand to make sure that doesn't happen. Director Barkett asked if the award can be awarded for the benefits of Cannabis and not the potency of THC? Chair Durfee related that several speakers have mentioned that the THC is a basic component. Like judging strawberries without testing for sweetness. Director Salinas asked that Cultivar repeat how many categories. Brian Applegarth explained there are 3 Divisions (Indoor, Mixed Light, Outdoor), Ten categories in each Division, 7 terpene categories with 1 co-dominant terpene profile and 3 cannabinoids categories. This competition is seeking to educate on the whole plant biology and the therapeutic properties present in all parts of the raw plant. Director Chong stated that this is a very complex situation. Cannabis is here to stay and we should educate ourselves. So hearing the pros and cons are part of the education process. Chair Durfee asked for more discussion seeing none let's move to a vote.

### MOTION:

The motion before the board is to continue as planned with the Cannabis competition at State Fair with addressing Director Hime's concerns about the

use of our logo. Chair Durfee asked for a roll call vote Director Barkett; no; Director Choi, yes; Director Chong, yes; Director DiMare, no; Director Gbeh, yes; Director Mallel, yes; Director May, yes; Director Salinas, yes; Vice Chair Hime, no; Chair Durfee, yes; **By a vote of 7 to 3 Motion carries.**

- More THCa = More THC when you smoke it
- CBGa is a precursor in the plant of both THCa and CBDa
- Pinene for example is a known respiratory irritant with recommended exposure The terpenes you are awarding are also not necessarily safe for inhalation -
- + In summary, these prizes are not "science-based"



# Cannabis has changed profoundly




Figure 2, Marijuana, from Monitoring the Future national survey results on drug use, 1975-2020. Volume 2. Image credit:

## High potency cannabis is far more dangerous

- + Develop cannabis use disorder more

Subject: Code of Conduct - Public Comment Review

#### BACKGROUND

In 2016, the California Exposition and State Fair (Cal Expo) codified its general practices for health and safety into a Code of Conduct. The Code of Conduct is a resource used by Cal Expo to help further inform patrons and event promoters of acceptable behaviors when they engage in activities at Cal Expo. The COVID Pandemic created changes in approaches to health concerns and events across the country over the past two years. Consequently, Cal Expo reevaluated its health and safety policies to identify potential improvements.

Enhancements to the Code of Conduct have been proposed with an aim to help keep the upwards of 3,000,000 annual guests healthy and safe while enjoying their time at the State Fairgrounds. These enhancements are geared to provide a safer working environment for Cal Expo employees and volunteers. The most notable proposed changes involve instituting a new "clear bag" policy, creating a mask exception for health purposes, and instituting a new policy regarding unaccompanied minors on weekend evenings during the State Fair.

These proposed policy changes were initially reviewed at the April 29, 2022, Board Meeting and subsequently placed on Cal Expo's website for a 30-day public comment period.

### CHANGES IN CODE OF CONDUCT

The current Code of Conduct reads: "Masks that obscure the whole face, including but not limited to clothing, ski or Halloween masks". Staff is recommending the following: "Items that obscure the face, including but not limited to clothing, apparel or masks with the exception of health face masks."

In order to further assure the safety of patrons, the safety of employees, and to expedite security screenings at Admission Gates, Staff recommended a Clear Bag policy that is like other event venues in Sacramento (Heart Health Park at Cal Expo, Sutter Health Park – River Cats, and the Golden 1 Center.) The proposed Clear Bag policy is considered an industry standard of best practices for checking bags when attendees enter large events. The policy limits the size and type of bags (so that security personnel can easily see the entire content) with exceptions for medical or childcare needs. Small clutch purses are also allowed for privacy for small personal items, and also is easily searched.

In 2019, several State Fairs instituted policies to address unaccompanied minors due to related disturbances. Coming out of the Pandemic, Fairs across the country have experienced a sharp increase in issues in the evenings on weekends with unaccompanied minors creating disturbances that interfere with other guests' enjoyment of the event. The State Fair has experienced similar issues with unaccompanied minors during weekend evening hours. These issues escalated during the Carnival event at Cal Expo in 2021, and predominantly involved unaccompanied minors, some as young as 12 years old. Several community leaders attended this event and assisted security in attempting to address these minors.

In order to further assure the safety of patrons, volunteers, and employees, Staff recommended a policy that will require minors under the age of 18 to be accompanied by an adult (21+) when they enter or reenter the California State Fair after 6:00 PM on Fridays, Saturdays, or Sundays. If disruptive behaviors shift to occur on Mondays-Thursdays, the policy would be adjusted accordingly.

This policy does not impact employees of food and commercial vendors, etc., that are minors, as these employees typically begin their work shift before 6:00PM on weekends. Minors who participate in the State Fair's competitive programs would be provided access to care and feed their animals – which is typically under adult supervision. Minors wishing to enter the State Fair after 6:00PM without being accompanied by an adult, may do so Monday-Thursday.

### **PUBLIC COMMENTS**

During the public comment period, few responses were submitted. Of which most were positive and supportive. One commenter disagreed with all changes but did not state any of the reasons why. A local community group, Empact, supports all three changes

to the code of conduct and are appreciative of our efforts to improve our protocols while prioritizing the safety and security of the community. Another community group, The Village Advocates, wrote in support of the updates saying they are in compliance with our mission statement and offered some suggestions for the future.

## RECOMMENDATION

Staff recommends approval of the above outlined changes listed below made to Cal Expo's Code of Conduct.

- 1. Items that obscure the face, including but not limited to clothing, apparel or masks. The wearing of health face masks may be permitted.
- 2. Bags and purses entering CE&SF must follow the Clear Bag policy. All bags and purses must be either a clear plastic, vinyl, or PVC no larger than 12"x12"x12"or a one-gallon clear plastic bag (Ziploc or similar) plus a small clutch purse that does not exceed 4.5" x 6.5".
- 3. Minors under the age of 18 must be accompanied by an adult (age 21+) when they enter or reenter the California State Fair after 6:00 PM on Fridays, Saturdays, or Sundays.

In my personal opinion these problems are parental problems and we do a disservice by not putting the burden of responsibility back on the parents.

It is also my suggestion: If you want this to work, you need to include a parent pass, so parents don't have to be burdened with having to pay to supervise their kids. Have adult games, TV, music, etc. Maybe institute an announcement overhead to call parents when needed or give out parent pagers...
